WHAT IS AIR FORCE ROTC?

The Air Force Reserve Officer Training Corps (AFROTC) is an educational program designed to give you the opportunity to become an Air Force or Space Force officer while completing an undergraduate degree. The AFROTC program is designed to prepare you to assume positions of increased responsibility and importance in the modern Air Force. AFROTC is offered at over 700 institutions throughout the continental U.S., Hawaii, Alaska, and Puerto Rico.



THE FOUR-YEAR PROGRAM

AFROTC consist of two years in the General Military Course (GMC) learning the basics of the military. Cadets then enter the Professional Officer Course (POC), where cadets plan and execute weekly Leadership Laboratories, in which they are responsible for training and instructing GMC cadets.

SHOW ME THE MONEY!

As of Jan 2025, a Second Lieutenant (2Lt) earns \$3,998 a month base pay. All military members receive some form of housing allowance or live rent free on a military installation. A 2Lt living off-base in Montgomery, Alabama without dependents, will receive \$1650 a month Basic Allowance for Housing. This allowance is non-taxable. Additionally, all officers receive an untaxed Basic Allowance for subsistence, which is currently \$ 320 a month. Your monthly gross income will be \$5968; an annual income of \$71,616

WHAT ABOUT SCHOLARSHIPS?

High School: To be eligible for AFROTC scholarship consideration while in high school, you need to have at least a 26 ACT or an 1240 on the SAT (Math and Critical Reading portions only) and have a cumulative GPA of 3.0 or higher. The items that make an

College: Air Force does offer scholarships to cadets, pending Federal Budget Availability. Additionally, some colleges offer departmental level and or school level aid for cadets.
